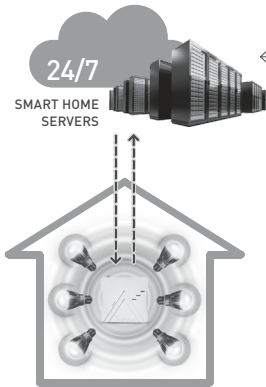

Turn ON your wall switch

Activate inclusion mode on your Z-Wave controller



### STEP 4

Activate inclusion mode of the RGBW bulb by REPEATEDLY TAPPING the bulb

■ Configuration option 1 is used to adjust color temperature. Values range from 1 to 100 where 1 means full cold white and 100 means full warm white.

A factory default reset is performed when the bulb is excluded from the Z-Wave network. Please use this procedure only when the network primary controller is missing or otherwise inoperable.

## HOW TO ACTIVATE INCLUSION OR EXCLUSION MODE

Inclusion and exclusion modes are activated by repeatedly tapping the light bulb. The light bulb will shine green to indicate a successful activation of inclusion or exclusion mode.
